List of documents required to grant provisional residence for <u>trainees graduates of higher</u> education

- 2. Proof of extension of the foreigner's transfer from an EU Member State to the branch or representative office in the Republic of Moldova, including the period of the transfer, the location and the foreigner's remuneration
- 3. A copy of study diploma translated into Romanian
- 4. Alien's national passport (original and copy) with the appropriate entries applied by the state border control body (confirming the date and place of crossing the state border)
- 5. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the state of nationality. If the alien has been legally residing for at least two years in a country other than the state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence.
