FAMILY REUNIFICATION

A. Family reunification with a citizen of the Republic of Moldova

List of documents required for granting the right of provisional stay for family reunification with a citizen of the Republic of Moldova:

- 1. Standard Application Form
- 2. Applicant's national passport (original and copy) and a copy of the long-stay visa (for foreigners entering based on visa)
- 3. Marriage certificate (original and copy) transcribed in the Civil Register of the Republic of Moldova
- 4. Valid identity card (original and copy) of the citizen of the Republic of Moldova
- 5. Child's birth certificate (original and copy) transcribed in the Register of Civil Status of the Republic of Moldova
- 6. The original and a copy of the document proving the right of ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 7. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the State of nationality. If the alien has been legally residing for at least two years in a country other than the state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years of age.
- 8. Health insurance (original and copy) valid for at least 3 months (except for minors)
- 9. A 3x4 cm color photo.

List of documents required for extension of the right of provisional stay for family reunification with a citizen of the Republic of Moldova:

- 1. Standard Application Form
- 2. Applicant's national passport (original and copy)
- 3. Residence permit (a copy)
- 4. Marriage certificate (original and copy) transcribed in the Civil Register of the Republic of Moldova
- 5. Valid identity card (original and copy) of the citizen of the Republic of Moldova
- 6. Child's birth certificate (original and copy) transcribed in the Register of Civil Status of the Republic of Moldova
- 7. The original and a copy of the document proving the right of ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 8. A 3x4 cm color photo.

B. Family reunification with a foreign national

List of documents required for granting the right of provisional stay for family reunification with a foreign citizen:

- 1. Standard Application Form
- 2. Applicant's national passport (original and copy) and a copy of the long-stay visa (for foreigners entering based on visa)
- 3. Marriage certificate (original and copy) transcribed in the Civil Register of the Republic of Moldova
- 4. Valid identity card (original and copy) of the family member, proving his/her legal stay on the territory of the Republic of Moldova (residence permit or identity card for stateless persons)
- 5. Child's birth certificate (original and copy), legalized/apostilled (in the established manner), translated into Romanian and notarized or consular authenticated.
- 6. The original and a copy of the document proving the right of ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 7. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the State of nationality. If the alien has been legally residing for at least two years in a country other than the State of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years old.
- 8. Health insurance (original and copy) valid for at least 3 months (except for minors)
- 9. Proof of means of support in the amount corresponding to the category of the right of residence applied for.
- 10. A 3x4 cm color photo.

List of documents required for extension of the right of provisional stay for family reunification with a foreign national:

- 1. Standard Application Form
- 2. The applicant's national passport (original and copy)
- 3. Residence permit (a copy)
- 4. Marriage certificate (original and copy) legalized/apostilled, translated into Romanian and notarized or consular authenticated.
- 5. Valid identity card (original and copy) of the family member, proving his/her legal stay on the territory of the Republic of Moldova (residence permit or identity card for stateless persons)
- 6. Child's birth certificate (original and copy), legalized/apostilled (in the established manner), translated into Romanian and notarized or consular authenticated.
- 7. The original and a copy of the document proving the right of ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 8. Proof of means of support in the amount corresponding to the category of the right of residence applied for.
- 9. A 3x4 cm color photo.

C. Family reunification - procedure for family members

List of documents required for granting the right of provisional stay to family members:

- 1. Standard Application Form
- 2. Applicant's national passport (original and copy) and a copy of the long-stay visa (for foreigners entering based on visa)
- 3. Residence permit (original and copy)
- 4. Original and copy of birth certificate (in case of reaching the age of majority); divorce certificate, death certificate.
- 5. The original and a copy of the document proving the ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 6. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the state of nationality. If the alien has been legally residing for at least two years in a country other thanthe state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years of .
- 7. Proof of means of support in the amount corresponding to the category of the right of residence applied for.
- 8. A 3x4 cm in color photo.

List of documents required for extending the right of provisional stay for family members:

- 1. Standard Application Form
- 2. The applicant's national passport (original and copy)
- 3. Residence permit (original and copy)
- 4. Original and copy of birth certificate (in case of reaching the age of majority); divorce certificate, death certificate.
- 5. The original and a copy of the document proving the right of ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 6. Proof of means of support in the amount corresponding to the category of the right of residence applied for.
- 7. A 3x4 cm color photo.

D. Family reunification with partner citizen of the Republic of Moldova

List of documents required for granting the right of provisional stay for family reunification with a partner - citizen of the Republic of Moldova:

- 1. Standard Application Form
- 2. Applicant's national passport (original and copy) and a copy of the long-stay visa (for foreigners entering based on visa)
- 3. Civil status certificate (in original) of the applicant (single, divorced, widowed)
- 4. Civil status certificate (in original) of the partner of the citizen of the Republic of Moldova
- 5. Valid identity card (original and copy) of the citizen of the Republic of Moldova
- 6. Birth certificate (original and copy) of the joint child, transcribed in the Civil Status Register of the Republic of Moldova.
- 7. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the state of nationality. If the alien has been legally residing for at least two years in a country other than the state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years old.
- 8. Health insurance (original and copy) valid for at least 3 months (except for minors under 16 years old)
- 9. A 3x4 cm color photo.

List of documents required for extending the right of provisional stay for family reunification with a partner-citizen of the Republic of Moldova:

- 1. Standard Application Form
- 2. Applicant's national passport (original and copy)
- 3. Copy of residence permit
- 4. Civil status certificate (in original) of the applicant (single, divorced, widowed)
- 5. Civil status certificate (in original) of the partner of the citizen of the Republic of Moldova
- 6. Valid identity card (original and copy) of the citizen of the Republic of Moldova
- 7. Child's birth certificate (original and copy) transcribed in the Civil Status Register of the Republic of Moldova.
- 8. The original and a copy of the document proving the right of ownership or use of the dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation).
- 9. A 3x4 cm color photo.

NOTES:

- 1. The documents must be submitted at least 30 days before the authorized end of foreigner's stay in the Republic of Moldova.
- 2. The EU citizens must submit their documents at least 15 days before the authorized end of their stay in the Republic of Moldova.
- 3. Failing to meet the deadline for application is subject to administrative penalties
- 4. Presence of both family members is compulsory when submitting the documents.
