A. Humanitarian activities

List of documents required to grant the right of provisional stay for humanitarian activities

- 1. The public association's Request and the Standard Application Form
- 2. Alien's national passport (original and copy) with appropriate references made by the state border control authority (confirming the date and place of crossing the state border) and the copy of long-stay visa (for foreigners entering on a visa);
- 3. Original and copy of the registration certificate, original and copy of the extract from the Register of non-commercial organizations
- 4. Original and copy of the cooperation contract
- 5. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the state of nationality. If the alien has been legally residing for at least two years in a country other than the state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years of age.
- 6. Original and a copy of the document proving the right of ownership or use of dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation)
- 7. Original and copy of the health insurance valid for at least 3 months
- 8. Proof of means of subsistence and treatment in the amount corresponding to the category of residence applied for;
- 9. A (one) 3x4 cm color photo.

List of documents required for extension of the right of provisional stay for humanitarian activities

B. Religious activities

List of documents required to grant the right of provisional stay for religious activities

- 1. The religious denomination's Request and the Standard Application Form
- 2. Applicant's national passport (original and copy) with appropriate references made by the state border control authority (confirming the date and place of crossing the state border) and the copy of long-stay visa (for foreigners entering on a visa);
- 3. Original and copy of the registration certificate, original and copy of the extract from the Register of religious denominations and their component parts
- 4. Original and copy of the cooperation contract
- 5. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the state of nationality. If the alien has been legally residing for at least two years in a country other than the state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years of age.

C. Volunteer activities

List of documents required to grant the right of provisional stay for volunteer activities

- 1. The public association's Request and the Standard Application Form
- 2. Alien's national passport (original and copy) with appropriate references made by the state border control authority (confirming the date and place of crossing the state border) and the copy of long-stay visa (for foreigners entering on a visa);
- 3. Original and copy of the registration certificate, original and copy of the extract from the Register of non-commercial organizations
- 4. Original and copy of the volunteering contract
- 5. Criminal record (in original) from the applicant's country of origin, legalized/apostilled by the authorities of the state of nationality. If the alien has been legally residing for at least two years in a country other than the state of his/her nationality, he/she shall present the criminal record or another document with the same legal value issued by the authorities of the country of residence, translated and legalized/apostilled, as well as the document confirming the right of residence, except for minors under 16 years of age.
- 6. Original and a copy of the document proving the right of ownership or use of dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation)
- 7. Original and copy of the health insurance valid for at least 3 months

List of documents required for extension of the right of provisional stay for volunteer activities

- 4. Original and copy of the registration certificate, original and copy of the extract from the Register of non-commercial organizations
- 5. Original and copy of the volunteering contract
- 6. Original and a copy of the document proving the right of ownership or use of dwelling (extract from the Register of Immovable Property or rental contract, registered in accordance with the legislation)
- 7. Original and copy of the health insurance purchased from the National Health Insurance Company
- 8. Proof of means of subsistence and treatment in the amount corresponding to the category of residence applied for
- 9. A (one) 3x4 cm color photo.

NOTES:

- 1. The documents must be submitted at least 30 days before the authorized end of foreigner's stay in the Republic of Moldova.
- 2. The EU citizens must submit their documents at least 15 days before the authorized end of their stay in the Republic of Moldova.
- 3. Failing to meet the deadline for application is subject to administrative penalties.
